
Report Unclaimed Property

Create Account

The fields for **Email address** and **Account Identification Number** will be automatically populated. Enter your contact information, as well as information for a secondary contact. This information is collected so that the Director may contact the holder/remitter, should questions arise, and for FundsFinderNB to send messages/receipts/invoices relating to the submission to the person (user) making the submission. Secondary contact information is collected in case the primary contact is unavailable.

All fields are required. For the **Preferred language** fields, select the magnifying glass symbol, which will bring up the choices for language.

Review the User Agreement (which can be found under the **Resources** menu at the top of any page), and, if you agree to the terms, select the box next to **I agree to the portal terms of use** and select **Update** to save your profile information.
